#### LEARNING GOALS

The aim of the course is to introduce students to the themes of urban and territorial history, focused on the complex stratigraphy that characterises cities and landscape, in order to acquire a greater historical consciousness of the intervention area. The course traces the most emblematic events from the foundation to the 19th century bourgeois city. The course aims to provide scientific tools for learning how to correctly read and interpret the signs present in the city and on the territory. These have to be framed in the right historical perspective, extending the principle of heritage to the different architectural scales.

The course is divided into two parts. In the first one, the history of the city will be briefly illustrated

in relation to the different political and cultural governments. In the second part, the student will be guided to the analysis of an urban context through city-tours in order to allow the historical-critical interpretation of the urban palimpsest in function and in relation to the other disciplines that contribute to the Design Studio for Urban Heritage.

## **EXPECTED LEARNING OUTCOMES (DUBLIN DESCRIPTORS)**

### **Knowledge and understanding**

The student has to demonstrate knowledge of:

- 1) know and interpretate the shape of the soil within an urban settlement arose;
- 2) know and interpretate the main urban events that marked the articulated framework of the urban development;
- 3) identify and interpretate the architectural and urban resiliences still *in situ*;
- 4) critically read the historical cartography.

### **Applying knowledge and understanding**

The student has to demonstrate knowledge of:

- 1) elaborate discussions, also if complex, concerning the assumptions and inescapable contingencies of urban growth and landscape transformation;
- 2) develop a critical-interpretative capacity of the built heritage in relation to the architectural, urban and territorial history;
- 3) apply investigation methods starting from sources and from the autoptical experience for the knowledge of the material, morphological, typological, constructive and structural aspects of the built heritage;
- 4) use digital humanities tools for the critical representation of the built heritage in its historical recognition;
- 5) organize strategies to identify, recover, utilise and safeguard the values of the built heritage;
- 6) develop a communication project for the identified built heritage.

## **COURSE CONTENT/SYLLABUS**

### **Part I - History of the city and the territory**

Learning the urban dimension in relation to political and cultural domination for a historical awareness of the project: the Greek city; the Roman city; the early medieval city; the city in the early modern age; the city in the viceregal age; the capital city; outlines of the history of the post-unification city; the historical cartography and city portrait.

### **Part II - Planning the historical narrative**

Reading the insula of the Santa Chiara complex between urban growth for sharing the history instances in a contemporary perspective. The urban settlement of the ancient part of the historic centre of Naples: reading, interpretation, cartographic representation and palimpsest narration.

### b) Evaluation pattern

To take the exam, the student must have participated in all the didactic activities and been evaluated positively in the general meetings scheduled in the semester. The exam involves the discussion of the research and studies carried out by the group through the presentation of drawings (which final version has to be also shared in digital and printed version in book A3 paper format at the end of the course) and examination of the acquired knowledges about the topics dealt with during classes, considering the bibliography and the city tours.

The final grade, because of the outcomes and skills demonstrated in the discussion of the project as well as the themes and elaborations from the different modules, will be weighted on the CFUs of each teaching and thus composed as follows: Urban design for heritage 33%; Urban conservation 22%; Urban and territorial history 22%; Urban planning for the historic city 22%.
